O R D E R :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P TRANSCO, SEVENTY ONE Assistant Engineers/Elecl and TWENTY ONE Addl. Asst. Engineers/Elecl mentioned in the Annexure appended to this order are promoted temporarily to act as Asst. Divisional Engineers/Elecl with effect from the date of assuming charge.

2. These promotions are in the ratio of 1:3:1 as per Note-1 of Reg. 6(b) of A.P.S.E. Board S.Rs – Part-III as adopted by A.P. TRANSCO.
3. The promotions ordered in para-1 above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto. The promotions ordered above are subject to result of appeals filed by the retired officers of erstwhile APSEB against the judgement in W.P.Nos. 2360-91/83 and pending in the Hon'ble Supreme Court and W.P. Nos. 7074/93, 17126/93, 14366/89, 5005/90, 5432/92, 25178/96, 16273/98, 16587/2006, 12852/2008 & 12129/2008 pending in the Hon'ble High Court of Andhra Pradesh. These promotions are also subject to result of Writ Petitions pending in the Hon'ble High Court of A.P., regarding seniority.
4. The promotions ordered above are also as per the Rule of reservation in promotion in favour of S.Cs & S.Ts as adopted by A.P TRANSCO.
5. The promotions ordered in para-1 above are also subject to receipt of clarification from the Special Chief Secretary, Energy Department, Govt. of A.P sought vide Letter dt:29.05.2009 regarding maintenance of two separate rosters and to maintain adequate representation of SCs/STs in the cadre of ADE from AE and AAE cadres separately.
6. The promotions ordered in para-1 above are also subject to the result of the W.P.No.28932 of 2008, W.P.No.2189 of 2009, W.P.No.16185 of 2009 and W.P.No.23380 of 2009 pending in the Hon'ble High Court of A.P.
7. The SEVENTY ONE Assistant Engineers/Elecl., and TWENTY ONE Addl. Asst. Engineers/Elecl., mentioned in the Annexure appended to this order, on their temporary promotion as Assistant Divisional Engineers/Elecl ordered in para-1 above, are allotted to the control of Chief Engineers as indicated against their names each. The concerned Chief Engineers are requested to issue reposting orders in the existing vacancies under their control by conducting counseling to the candidates as per seniority mentioned in the Annexure, under intimation to the Head Quarters.
8. The concerned Controlling Officers are requested to relieve the above promotees by making local arrangements pending posting of substitutes in order to enable them to assume charge on promotion as Asst. Divisional Engineers/Elecl at the place of posting ordered.

9. The AEs/AAEs(Elec) are directed to assume charge on promotion as Asst. Divisional Engineers/Elec., at the place of posting ordered, after obtaining proper relief from the present place of working.

10. The promotees are informed that requests for change of posting will not be entertained and they shall assume charge accordingly after obtaining proper relief within fifteen days from the date of receipt of reposting orders, failing which they have to forego all the rights both present and future for such higher posts. If they fail to join duty within the time limit or evade to join duty such period till they re-join will be treated as un-authorised absence, besides treating such period of un-authorised absence as 'DIES-NON', they shall also be liable for disciplinary action.

11. The date of joining of the candidate on promotion as ADE/Elec., will be reckoned as date of commencement of probation.
